- 3. How might volunteering in a prison positively impact the prisoners? The volunteers?

# **Key Definitions**

- Rehabilitation the process of restoring someone (such as a criminal) to a useful and constructive place in society (Merriam-Webster.com)
- Solitary confinement the housing of an adult or juvenile with minimal to rare meaningful contact with other individuals (National Commission on Correctional Health Care)
