## **Key Definitions** (from Merriam-Webster Dictionary)

- Recreational drug a drug used without medical justification for its psychoactive effects, often in the belief that occasional use of a substance is not habit-forming or addictive.
- Medical cannabis available only by prescription and is used to treat a variety of medical conditions such as pain, anxiety, nausea, and glaucoma.


