Conversation Questions

- 1. How does using the word "reproductive" shape the way we talk about bodies and rights?
- 2. What are ways that our bodies are affected by societal norms and laws? How does the idea of justice come into it?

Key Definitions

- Bodily autonomy Concept that individuals have the right to control what does and does not happen to our bodies. (From Positive Women's Network)
- Informed consent The right to help decide what medical care to receive. By law, health care providers must explain health conditions and treatment choices. (Adapted from MedlinePlus Encyclopedia)

This book excerpt summarizes the changes in abortion law throughout US history.


"G: Unfit" from Radiolab
